A RESOLUTION OF THE BOARD OF COMMISSIONERS OF LEDGEWOOD BEACH WATER DISTRICT, ISLAND COUNTY, WASHINGTON, SETTING WATER RATES AND CHARGES.

WHEREAS, Resolution #101 of the Ledgewood Beach Water District, dated March 8, 2022, set water rates and charges for a five-year period; and

WHEREAS, water rates & charges pay for the operations of the Ledgewood Beach Water District, the maintenance of the Newell Firehouse and provide funding for the Capital Fund to cover major repairs of the water system; and

WHEREAS, it is the desire of the Ledgewood Beach Water District Board of Commissioners to consolidate all fees, rates & charges into one resolution.

NOW THEREFORE, BE IT RESOLVED; that the Commissioners of Ledgewood Beach Water District, Island County, do hereby authorize the Basic Charge per meter per quarter be as follows:

Effective March 16, 2022	\$114.00	\$5.25 increase over \$108.75 rate (4.83%)
Effective March 16, 2023	\$119.00	\$5.00 increase over \$114.00 rate (4.39%)
Effective March 16, 2024	\$124.00	\$5.00 increase over \$119.00 rate (4.20%)
Effective March 16, 2025	\$129.00	\$5.00 increase over \$124.00 rate (4.03%)
Effective March 16, 2026	\$134.00	\$5.00 increase over \$129.00 rate (3.88%)

NOW THEREFORE, BE IT FURTHER RESOLVED; that the FEE & RATES for water costs and other charges of the Ledgewood Beach Water District be as follows:

<u>Un-Readable Meter</u> - Billed at 5,000 Cubic Feet quarterly for a meter deemed unreadable due to a customer's actions

Use of the Newell Firehouse - Charges and deposits for use of the Firehouse are as follows:

Standard rate:	\$20 for 4-hour window - \$30 for a full day
Ratepayers and residents:	\$ 5 for 4-hour window - \$ 7 for a full day
Registered non-profits:	\$ 5 for 4-hour window - \$ 7 for a full day
